VP Lakeview: Maureen Magis:

- Maureen reported that the gate at the playground has been moved from Tahoe to Timberlake to assist the airboat in navigating the path to be able to access the water for testing.
- Maureen/John: We will be doing some necessary maintenance work at that boat launch in order to ensure a safe and accessible area for the lake testing boat. This includes, adding sand, large rocks to build up the launch area which has settled over time (approx 6 yrs since last done), and repairing/replacing the waterfront gate and it's support structures. Also, the Climbing Dome will need to be moved, we are currently getting price quotes for these.
- Future plans to provide an adequate path to get the boat to the lake for treatment and improve that space, opening up more usable space in the playground & alleviating the boat trailer divots in the sand are also being researched and considered.
- We have plans to change the codes to the gates at the Beach & Playground for the 2023 season. Members in good standing will receive postcards in the mail with the new code prior to Memorial Day Weekend.
